I hereby declare and agree as follows:

1. All my personal details set out above are in all respects true and correct.
2. I hereby unconditionally and irrevocably submit to the authority, the constitution and all the rules, regulations, requirements and directives of the DTS / Kamikaze Inline Hockey (Kamikaze) in respect of my participation in any recreational or competitive inline hockey, and agree to be bound thereby. More specifically, I agree that it is my duty to know and understand the constitution, rules, regulations, requirements and directives of DTS / Kamikaze Inline Hockey.
3. Inline hockey is a potentially dangerous sport and poses the risk of serious personal injury, as well as damage to or loss of property for players, participants and spectators. I assume this risk and agree that my participation in any recreational or competitive inline hockey is entirely at my own risk.
4. My participation in any activities whatsoever which may be offered or conducted by Kamikaze is likewise entirely voluntary and at my own risk. For the purposes of this indemnity and waiver, the expression 'activities' includes, but is not limited to any recreational games or official or national tournaments and recreational or social events of Kamikaze.
5. I will not hold the DTS or Kamikaze liable in respect of any of their negligent acts or omissions which may cause me personal injury, or patrimonial losses or damage (including any (i) direct damages or (ii) consequential damages or pure economic loss); and I hereby waive any and all such claims that I may have in law against the DTS or Kamikaze or its members in respect of any such personal injury, or losses or damages to the fullest extent allowed by Namibian law; and I hereby indemnify and hold Kamikaze or its members harmless against any and all such claims by myself and any third party claiming or entitled to claim on my behalf to the fullest extent allowed by Namibian law.
6. I will be punctual for training and be fully dressed on the court at the stipulated training time
7. I will be respectful to the coach and towards my team members
8. I will participate fully in the training and adhere to the instructions of the coach

9. The coach has the final decision in making up the teams for NIIHA tournaments and I will respect such decision.
 10. I will address any issues with the coach and the team and if it cannot be resolved then I have the option to approach the committee.
 11. I respect the decisions that are made for and in the best interest of the team.
 12. I will participate in at least 3 (three) NIIHA tournaments.
 13. I will inform the coach, the team manager and my team members the reasons why I cannot participate in a tournament and/or training.
 14. I will abide by the rules of NIIHA and the NIIHA Code of Conduct.
 15. I understand that the Club is run by volunteers and hence I undertake to help at all events organized by Kamikaze. These events include, but are not limited to:
 - Roller disco, Iron Man Tournament, Volleyball for All, the Annual Kamikaze Tournament, involvement in Social Braais.
 16. I will be at the maintenance day to help maintain the court on which I train and play during the year.
 17. The committee may decide on a penalty fee applicable if I fail to help in the tournaments and maintenance day.
 18. I will honor the payment of my invoices and if I encounter financial difficulties in paying my accounts, I will promptly inform the committee and make arrangements to settle all outstanding invoices.
 19. I agree to the "No Pay, No Play" rule, where in case my account is overdue, I will not be allowed to play at tournaments.
